- Affirm EC support for ongoing discussions for DAC co-location. *Please keep confidential* until discussions have concluded. Further discussion to be held by email.
- DAC SCC and SEMI seek to co-locate DAC with SEMI (on SEMICON West dates 2nd week of July). Belief is that if this does not happen support of prominent EdA CEO's will be lost as we move forward.
  - Negotiations in progress to ensure DAC remains independent and SEMI supports exhibition by keeping all EDA/Design-related items under DAC's purview. Revenue sharing model to be developed as a next step. No revenue sharing in 2020, assuming 2020 co-location.
  - We have challenges
    - ability to manage our own space exhibition/meetings and hotel
    - Long Term commits to keep DAC exhibition integrated and viable
    - non-compete in DAC/design activities.
  - Discussions for 2020 were called off as DAC EC felt it could not overcome some challenges. To accelerate/motivate co-location SEMI is offering a rent free Moscone West in San Francisco for 2020 (\$135,000).
  - These issues are being discussed; believe we will reach some conclusion in next 2 weeks. If DAC EC supportive colocation may happen for 2020.
