November 2023 TAB Meeting Recap - Nam

TCAS-AI Journal

CAS, SSCS, and CEDA Presidents and President-Elects reached an agreement on the TCAS-AI Journal sponsorship. Financial sponsorship shares will be CAS (57%), SSCS (15%), and CEDA (28%). The management committee will be composed of CAS (3), SSCS (1), and CEDA (2) with a chair position appointed by CAS. The title will be Transactions on Circuits and Systems for Artificial Intelligence (TCASAI), because the title was already approved by TAB. CAS will submit Phase 2 on December 15. Phase 2 will be sent to Periodical Committee members on December 30. FinCom will review budget by January 2024. TAB will make their decision by February 2024. If approved, the MOU will be sent in February 2024. Gi-Joon thanked the EC members involved in getting the agreement together.

IEEE DiscoveryPoint Targeting Semiconductor Industry Segments

Gi-Joon highlighted the IEEE DiscoveryPoint Targeting Semiconductor Industry Segments. The program addresses the practicing engineers in all of the parts of the global semiconductors industry. There are 7 operational segments. They reached out to CEDA for the Electronic Design Automation (EDA) Tools and Intellectual Property (IP) Cores. Gi-Joon will serve on the committee for one year on behalf of CEDA. There was a discussion held on the anticipated outputs of the pilot program.

Kaufman Award - Nam

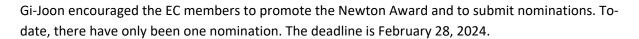
