Yao-Wen called the meeting to order at 9:04 am CST.

MOTION: It is moved to approve the March 2021 EC meeting minutes as written. Motion passed.

Presidents Update (Yao-Wen)

The Bylaws and Constitution were approved on March 22. The Ernest S. Kuh Early Career Award nomination deadline was extended to August 1.

DAC 2021 Updates (David)

The DAC Winter EC meeting was held on March 24-25. DAC was rescheduled to December 5-9 in San Francisco, CA, USA. A hybrid format was discussed with the virtual sessions being held the same week as the in-person event.

Several keynote speakers have been secured with a few additions being discussed. RISC-V will be colocated with DAC. As of April 16, there are 49 research paper sessions, 215 papers, 6 parallel sessions and a special session track.

Follow-up items include: Develop a DAC 2021 Blog/Vlog; send CEDA awards info to DAC organizers; and additional support for financially strained programs at DAC.

ACTION ITEM: Brooke and Subhasish to send DAC organizers which awards will be presented at DAC in December.

Awards Update (Subhasish)

A discussion was held on a lack of diversity and representation with CEDA's awards nominations and recipients with emphasis on gender and geographical representation. It was suggested to create a joint nomination committee between CEDA/ACM/SIGDA.

- The TCAD Donald O. Pederson Best Paper Award recipient was selected.
- The Richard Newton award decision was made.
- Kuh deadline was extended to August 1, however, as of April 16, the Council had received zero nominations. It was discussed how to promote the award better.
- The Kaufman HOF received two nominees.

ACTION ITEM: Subhasish to create committee to address the lack of diversity in CEDA awards and ensure proper nominations include gender and geographical diversity.

ACTION ITEM: Amanda to work with Vasilis to promote the Kuh award.

ACTION ITEM: Amanda to email Subhashish and Georges the qualified, rollover Kuh nominations. They will contact the nominators to update the awards form.
